- Increasing the number of people working in the community by partnering with others in the area and finding creative solutions to employment.
- Taking measures to recruit providers of services through our support of expanding educational opportunities and by meeting with new staff within 60 days of provider selection, providing training to ensure smooth life transitions.
- Continuing to keep our waitlist for waiver services minimized through focused intervention at every age.
- Investing in Early Intervention and Home Visitation programming by actively promoting positive childhoods for our youngest community members.

## **FINANCIAL RESPONSIBILITY**

The Hocking County Board of DD receives funding from local property taxes, state and federal funding. The largest source of revenue, approximately 80%, is supported by the voters of Hocking County. Remaining revenue flows from the state and federal governments and is utilized according to rules and regulations. In recent years, we have seen how the amount of support from state and federal governments has decreased. We are thankful for the support of our local community and commend the taxpayers for their commitment to giving back to their community. This funding is used to support all programs and services provided to people within our community who benefit from Medicaid waivers, Early Intervention, Help Me Grow Home Visitation and Family Support Programs. We are investing in the future of our county, to help people live their best life.
